Export Regulations

Export of night vision equipment and optical sighting equipment (including user manuals) is controlled by the U.S. Department of State Directorate of Defense Trade Controls, in accordance with the International Traffic in Arms Regulations (ITAR), Title 22, and Code of Federal Regulations Part 120-130 and/or the U.S. Department of Commerce Bureau of Industry and Security in accordance with the Export Administration Regulations (EAR), Title 15, Code of Federal Regulations Part 730. Some of this equipment may require a license for export or re-export from the United States. Any sale of equipment is intended to be made in strict compliance with U.S. export control laws. Diversion contrary to U.S. law is prohibited.

It is the purchaser's responsibility to request and obtain any required export licenses for the subsequent export or re-export of the subject items and to ensure that the requirements of all applicable laws, regulations and administrative policies are met. Export Compliance Acknowledgement Form
